- **The contracting client or organization agrees to pay an additional \$100.00 fee, in advance, for each additional hour or portion thereof over the scheduled time of the performance.
- **SWE cannot be held financially responsible for more than the above stated cost in case of equipment failure, vehicle failure or any other act of God.
- **A NON-REFUNDABLE DEPOSIT of half the total cost is due upon the return of this agreement.
- **The deposit will be surrendered as a service charge in case of customer cancellation.
- **The remaining amount owed will be due AT THE START OF THE EVENT payable by cash or money order made out to Sound Waves Entertainment LLC.
- **Performance agreements are due back within 15 days of date mailed; otherwise the date requested cannot be guaranteed.
